Agenda Item 1: Town Budget Documents

Discussion: K. Bocash led the overview and discussion of the Town Meeting Warrant Articles. According to the updated Budget Recap by Department the proposed town budget total will be \$6,609,996, and the Default budget will be \$4,995,952.

- The Default Budget total is significantly lower than the Proposed Budget
- Proposed Revenues are down from 2022, so even though the Proposed Budget reflects a decrease from the Approved Budget from 2022 there is an increase in the tax rate.
- Article 2: Municipal Operating Budget see totals above
- Article 3: Municipal Sidewalks Improvement no tax impact. The funds proposed for the sidewalks project will be withdrawn from the Capital Reserve Fund.
- Article 4 Public Works Truck Replacement This is for an advance purchase of a truck that will not be available until the following year.
- Article 5 Fire Department Grant, Tanker Replacement we did not receive this grant last year.
- Article 6 Ambulance Replacement the funds for the new ambulance will come from the Capital Reserve Fund for that purpose.
- Article 7 Increase Annual Deposit to the Ambulance Replacement & Equipment
 Fund the ambulance billing revenues need to be increased to deposit sufficient
 funds to the Capital Reserve Fund in order to be able to purchase and replace
 the ambulances as needed.
- Articles 8-19 appropriate funds to the Capital Reserve Funds to replace vehicles and equipment for the departments included in the town budget.

Agenda Item 2: School Budget Documents

Discussion: K. Bocash and B. Lane led the discussion and overview of the Warrant Articles (including the proposed budget, Article 1).

- Warrant Article 1: Operating Budget the Proposed Budget total is \$10,379,918 and the Default Budget is \$10,219,158.70. The estimated tax impact is \$0.39 and is recommended by the School Board (5-0). A YES vote would appropriate the Proposed Budget total and a NO vote would appropriate the Default Budget total.
- Warrant Article 2: Food Service Program this article allows the schools to receive Federal and State funds as revenues to support the School Lunch Program. There is no tax impact. A YES vote would allow \$330,000 to be received as revenues for this purpose and a NO vote would cause the schools to lose that revenue.
- Warrant Article 3: Recover and Expend Grant Funds this article allows the schools to receive Federal and Private Grant funds as revenues to support the School Educational Program. There is no tax impact. A YES vote would allow \$850,000 to be received as revenues for this purpose and a NO vote would cause the schools to lose that revenue.
- Preparation for the Public Hearing: Thursday, January 12 the meeting will begin
 with the School District Budget Proposal. The meeting will be held at the High
 School Auditorium and will be available in hybrid form with a GoToMeeting
 option.
 - o From B. Wheldon, regarding the meeting:
 - I've got everything finalized with Derek to make the public hearing tomorrow night be successful.
 - Those joining online will be able to ask questions; the audience and Budget Committee members will be able to hear through the microphone.
 - 2. Derek created a <u>Google Meets link</u> to the school Google Calendar posting for the meeting. He will share it out on their website, social media, etc. and can send it to Erica at the Town Office to post as well.

 - 3. Derek will be using two computers and a microphone to manage the Google Meets. It has worked well for their recent School Board meetings. They are planning to set it up tomorrow morning in the lecture hall. I will be at the school for the MS boys basketball game at 4 PM and will go down to do some testing at half-time.
 - 4. Derek offered to manage the Google Meets and/or work with a Budget Committee to do that. I will bring my laptop to assist Derek in managing on behalf of our Committee.
