Gerard: Second.

Discussion: Board members agreed the decision was based on someone with a financial background who could help at the school, someone who is not politically involved and would be a better mix with the current School Board members, someone who has a stake in helping with issues due to having children in the school, and a candidate who had run in the past and plans on running again in March to fill the position in the future.

Motion carried 5-0-0.

Adam Gauthier thanked Board members for taking the time to decide on a candidate to fill the vacant school board membership.

Dan Schroth said he agreed with Board members that Adam Cote was not so politically involved, but he still planned to run against Mr. Cote for School Board membership during the March election.

J.C. thanked the Board for adjusting the meeting schedule to accommodate his travel plans so he was able to participate in the vote.

J.C. also let the Board members know that on the upcoming agenda there will be a notice of intent to cut timber that an abutter has concerns regarding the access road. Cara will look into the bond requirements to make sure the town road is protected.


