# Agenda Item 2: Budget Process

#### Discussion:

- With the revaluation of properties there has been much discussion about the tax base and how the process is going to go this year.
- It appears that the revaluation increased all properties in town evenly and without a large increase in the budget the dollar amount taxed to taxpayers will remain even with past years.
- There don't seem to be any unforeseen expenses on the town side related to the Covid-19 issues.
- The status about the school is still in flux. There will be CARES Act money from the federal government to take care of the Covid-19 projects and changes. The School Board approved budgeted spending for insulation in the attic of the high

- school and several other projects. The SAU has a new superintendent and the School Board has encouraged the administrators to aim to keep the budgets relatively flat.
- Unlike last year we are not expecting any big changes or surprises. With the CIP put in place last year and several big projects proposed and completed things look good for a simpler process for us this year.
