Agenda Item 2: Budget Workbook Overview (cont...)

Discussion: we picked up the budget recap where we left off last week

- Code Compliance (lines 343 358)
 - We hired a new code compliance this year, the YTD salary reflects some pay for the building inspector (old position) and the code compliance officer (new position).
 - The proposed budget includes a pay raise and hourly raise for the code compliance officer.
- Solid Waste Disposal, Hydrant & Dam Fees (lines 474 479)
 - There is an increase in costs at BCEP which will be shared between the four communities. Our portion will be around \$4000 \$5000.

- Welfare (lines 493 515)
 - The proposed budget is basically a flat budget. The Welfare Director does what she can to direct people to resources available through other channels before using funds from this budget.
 - The instability during the COVID-19 time will be difficult to forecast but the welfare assistance is a mandated program that we must pay if applicants qualify.
- Parks & Recreation (lines 516 537)
- Library & Patriotic Purposes (lines 538 545)
- Conservation & Economic Development (lines 546 556)
- Debt Service (lines 557 559)
- Capital Outlay (lines 561 578)
- Waste Water Treatment Plant (lines 1 28)
 - Sewer Line Upgrades (line 28) shows an increase of approximately \$10,000 to slip-line a larger section of the sewer lines this year
 - The Select Board is looking into speeding up the upgrade project and possibly refinancing the bond we have for the sewer plant to free up some funds to perform the needed upgrades sooner than originally planned
