Discussion: Bryan Lane introduced himself. He then introduced the adequacy funds now available to the schools.

- Due to Covid-19 the State of NH and the Federal Gov't have made funds available to the schools to offset certain expenses and cover lunches for all students.
- \$358,696.76 has become available.
- The voters of Pittsfield have two options:
 - Vote to expend the funds and add to the school budgets
 - Vote to apply the revenue as a credit during the local tax rate setting process
- The Proposal to consider using the funds toward the operational budget of the school district includes the following matters:
 - The DOE has stated that \$239,527 would be recurring and we can expect this in the future
 - There is no Library Media Specialist at the school now, thus the proposal to fill the position
 - The Teacher and Staff positions proposed would be funded with monies expected to recur from the State of NH
- The School Board has not voted on these figures yet, but B. Lane presented these documents to the board at the last meeting
- There will be a Public Hearing on this matter at the High School, in the Cafeteria, tomorrow, September 9, at 5:30 pm.
- There will be a voting session in two weeks to consider these options.
- If the voters elect to apply the revenue to lower the tax rate, the decrease in the tax rate would equate to \$1.04 less
