Discussion: there were many questions and discussion about the pages in the workbook

- Still waiting on BCEP budgets
- Still waiting on CIP finalized outlook
- The Proposed Budget is relatively stable and straightforward, with only minimal increases across the board (salaries, retirement, insurance)
- K. Bocash led the discussion through the budget recap, department by department
 - There are good notes at the bottom of the pages of the budget workbook
 - o 4130 Executive
 - 4140 Elections, Registrations...
 - 4150 Financial Administration
 - The position of Town Clerk/Tax Collector is split in the budget workbook to departments 4140 and 4150

- The Office Assistant works in three different departments and 50% of her salary is in this department budget

 - There is an increase in Line 128 which covers the planning and zoning ordinance update for 2022
