- R. Schiferle introduced and discussed the budgets and tax rate for 2019 and the business ahead of us this budget season.
 - "How did we get to where we are today?" Information and reminders were
 provided to clarify changes that have occurred over the past year and the
 challenges ahead of us this budgeting season.
 - State education money (approx.. \$440,000) received by Pittsfield has been budgeted by the School Board to offset the tax rate.
 - H. Asdot gave an overview of some of the business being considered at the School Board. They will be receiving additional needed information from the state around November 15, 2019 and will be working to get us a draft budget soon.
 - The Capital Improvement Plan is being finalized and some numbers are starting to take shape. It appears that we will need to raise and appropriate approximately \$300,000 to bring the budgeted revenues up-to-date.

Agenda Item 2: Draft Town Budget

- R. Schiferle introduced the Draft Town Budget
 - There are 27 pay periods in the 2020 budget, as opposed to 26 pay periods in a normal year.
 - There is a 4.4% increase in health insurance for 2020.
 - There is an even distribution of technology/computer services by all departments.
 - There will be an property value assessment update done by Avitar which will cost the town \$66,300.
