Old Business:

ProServ/Gutter replacement/use of Jenkins Room: Downstairs is still not being used by patrons due to the basement taking in so much water during the storm on December 23rd. ProServ was called to clean up basement after the storm due to the unprecedented amount of water downstairs. Melissa and the trustees will attend the selectboard meeting on January 24th to see how we should proceed. Bestway has completed the moving of the gutter from the front of the building and reattached it to the side of the building.

Policy review: We made significant progress on updating our Emergency Procedures Policy at the meeting. AnneMarie will complete some additional changes and we will take up the discussion at our Febrary meeting.

Policy review: Our discussion on the Emergency Procedures Policy has been tabled until February. The trustees amended both the Technology Plan Policy and Library Open Hours and Holiday Closing Policy. A motion was made and seconded to accept both policies as amended. (Leslie/AnneMarie)

Library of Things update: The new items purchased have already started circulating.

Plans for Ruth Strickhart funds: There are passes to local recreational areas that are being offered at the library. Melissa is seeing where folks are interested in perhaps receiving passes from. If there is enough interest, buying such passes might be a good use of some of our funds. Programs for both children and adults alike also seem like a great way to use some of our donated Strickhart monies. Painting for adults, visits from children's authors, writing clubs were some of the ideas given.
