Item 2: Capital Reserve Funds – Equipment Replacement Plan

Town of Pittsfield Capital Reserve Funds – Equipment Replacement Plan

- Fire Department Pumper Capital Reserve: contributions increase from \$50,000.00 to \$100,000.00 through 2023 to bring the fund balance up to keep the schedule for replacement.
- Public Works Dump Trick Capital Reserve: contributions increase from \$30,000.00 to \$100,000.00 through 2022 to bring the fund balance up to keep the schedule for replacement.
- Fire Department Ambulance Fund: \$30,000.00 of billed funds are repurposed to the ambulance fund to keep the schedule of replacing an ambulance every 10 years.
