# Item 1: Pittsfield School Warrant Articles

## Documents Referenced:

- Pittsfield School District Warrant 2019 (DRAFT)
- Pittsfield School District Default Budget 2019-2020
- Article 1: School Lunch Program approval of the expenditure that is then covered by the sale of food, as well as state and federal funds. No tax impact.
- Article 2: Grant Funds to raise and appropriate grant funding for different programs in the schools. No tax impact.
- Article 3: Operating Budget / Default Budget -
- Article 4: Collective Bargained Contract Includes certain changes:
  - Teachers' health insurance splits going from 88/12% to 85/15% over three years.
  - Teachers salary guide increase of 2.5%
  - Other minor changes:
    - Certain dates specified in the contract
    - Definition of "teacher"
    - Rules regarding assignment change requests
    - Health Insurance Plan named
    - Changes in release procedure after July 15
  - Estimated tax impact:
    - \$0.55/thousand in 2019-2020
    - \$0.58/thousand in 2020-2021
    - \$0.61/thousand in 2021-2022
- Article 5: Special meeting authorization in the event that article 4 is defeated.
- Article 6: Dumpsters need to be replaced and a Capital Reserve Fund is being requested to consider this cost in the future. Estimated tax impact \$0.02/thousand.
- Article 7: Estimated cost of resurfacing and fencing of the tennis courts at Drake Field. Estimated tax impact \$0.14/thousand (a new estimate may reduce the cost of fencing).

- Discussion:
  - A copy of the School Bus contract was distributed to the committee.
  - $\circ$   $\,$  There are no copies of other districts' school bus contract for comparison.
  - There was a longer discussion on the number of students that use the bus system (the school does not keep track of that data).
  - A request was made to Dr. Freeman to give the committee an itemized list along with cost lines of programs/staffing that would most be looked for to add back into the budget.

- L. Houle informed the committee of a potential revenue relief project being worked on involving the installation of solar arrays on the roof of the municipal buildings in town and perhaps the schools.
