Application for Variance

Larry Konopka stated the fourth application to review is the Application for Variance. They have the new one and old one to compare.

Carole Dodge mentioned they used to have a space for the applicant to explain their intentions for the project and it would explain it better then what was in the criteria, and would like a section to be added for that.

Larry Konopka mentioned that if they change it too much it will take away from the context of the book. Carole Dodge stated that they are not changing a lot by adding a section for a paragraph that the applicant can explain their project. Pat Heffernan agreed with Carole that the paragraph was a simple way for the applicant to state what they want to do, for example squaring up a lot. Carole affirmed that and then stated that sometimes when the applicant fills out the criteria the simplicity of the intention is lost.

Larry Konopka called for a motion to approve the new Application for Variance to include a section for a paragraph to explain their project before the variance questions.

Carole Dodge: I make that motion.

Mike Cabral: Second.

Discussion: Larry Konopka inquired with the board about any questions for discussion and explained to Scott Aubertin that they are going through the applications to help streamline the process for the applicant and the board. He also explained they are going by the NH OSI handbook, members will receive a copy of the book.

Motion carries 4-1 Scott Aubertin abstains because he was not here for the whole discussion.

Appeal from an Administrative Decision

Larry Konopka stated the fifth one to review is the Appeal from an Administrative Decision. The board has an old one and a new one from the OSI book to review.
